This feature is an improved grassland field used as pasture. From the northern end of the field there is a level stretch some 59 metres long before the ground has a pronounced downward slope for a further 97m. to its lowest point before a gentle rise to the southern boundary adjoining the Ripley Road where there is a 1m. high bank with the hedge growing along its summit. There are no visible archaeological features visible. The 1854 OS map shows a stream running east to west across the field at its lowest point. This would now appear to be carried in an underground culvert.

History Summary

The field has remained unchanged from the mid 19th century until the present time, early 21st century.
