Contained and 1<sup>st</sup> (?) Rent every Messuage yearly payeth to the Kings Majesty(?) and 1<sup>st</sup>(?)  
Rent every Oxgang of the said land and every Acre yearly payeth and wholly Name holdeth  
at this Day every of the said Messuages and Acres of land and who payeth the same yearly  
at this Day and who yearly one after another for his or their land Messed(?) ought to Serve  
the \Kings Majesty as Grave of Scriven at all times hereafter.
